

Declaration about semi-finished and finished steel products in REACH.

Semi-finished and finished steel products, except for lead steels which, in any case, represent an amount lower than 0.35%, are considered **articles** according to Article 3 of Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December2006 **concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH)**, as recognized by ECHA in a letter to Eurofer dated September 2, 2009.

Therefore, they are not subject to registration.

On the other hand, the steels (articles) produced by Sidenor do not contain substances intended for release, or which release themselves, during their reasonable use, as indicated in Article 7 of the Regulation.

Likewise, our articles do not contain, substances above the declared thresholds (>0.1% of the weight), nor have these been added to them.

- They have not been subject to authorizations according to annex XIV
